

# Parenting Programmes

- Are you struggling to cope with your child's behaviour?
- Does it feel like your child's behaviour is getting out of control?
- Would you like to be managing your child's behaviour differently but don't know how?
- Do you need some time to learn new ways of coping with your child's
- behaviour?

# How can we help?

- It is important to stress that parenting has a major influence on the behaviour and actions of young people. How you behave as a parent directly influences how your children behave.
- Working with us will give you the opportunity to share experiences and learn new ways to manage difficulties.
- Evidence shows that if you feel supported you will feel more confident as a parent and your child's behaviour will improve as a result.
- We will work with you to decide if you need support with parenting and what sort of support will be of most help.

# Services available to support Positive Parenting

- We can provide you with advice and information about positive parenting.
- We can offer support to you on an individual basis, having agreed with you areas you want to work upon.
- There are a range of groups available, run by the YOT or by other agencies, where parents can learn from each others' experiences, and learn different ways of coping with teenage behaviour.
- A Family Group Conference can be arranged where you are supported in creating a plan to change behaviour.

Across West Berkshire a range of agencies provide support to parents in different ways, and we can put you in touch with them.

#### Areas which our work can cover

- Communicating with your child.
- Setting appropriate boundaries.
- · Dealing with conflict.
- Negotiating with your child.
- Rewarding good behaviour.
- Understanding teenagers and their development.
- How you can support as a parent.

# Parenting Order

- The courts are able to make a Parenting Order if a young person aged 10-17 years has committed a crime, or is engaged in anti-social behaviour.
- A Parenting Order will require you to meet with a Youth Offending Team Officer and to undertake work to develop your confidence and skills as a parent. You will be required to attend sessions for a maximum of twelve weeks, but the court may include additional requirements which can be for as long as a year.

# Our Aim

- We aim to give parents greater confidence in dealing with the behaviour of their children.
- We start from the belief that bringing up children can be a challenging task.
- We are not the experts you are the expert on your child. We aim to provide an external viewpoint which may help to solve difficulties.
- There is no one solution. We aim to offer a range of services and to find one which will best meet your needs.
