LONG STANDING ISSUEs Streatley FP21

4. MEMBERSHIP.

Following the resignation of Carole Ruse, Landowner and horse drawn carriage driver there is now a lack of landowners on the Forum.

5: WORKING METHODS OF THE FORUM.

The adoption of this document remains under discussion due to concerns raised by various members of the Forum, further drafting to continue.

6. READING ROWIP.

Lillian Green gave a presentation of the current status of the project and how it has been achieved. Julian suggested an audit of the local paths may be useful, he suggested this could be completed by May subject to various factors. Lillian accepted the proposed timescale and Margaret offered to assist regarding accessing the paths from a disabled viewpoint.

Action 6: Julian to respond to RBCs request for a LAF response to the RBC consultation on its RoWIP with support from those interested including Angus and Margaret.

7. UPDATE ON POLICY DEVELOPMENT INCLUDING SOLAR FARMS.

Some ongoing rewording needed as discussed but in general the policy has been agreed subject to these minor changes. Refined policy to be circulated to Forum members.

8. WOKINGHAM LOCAL PLAN.

Thanks to a very thorough job by Nicola a submission has been made on behalf of the Forum. As the Forum is there to support all user groups who have a right to use PROW's including walking, riding, cycling, disability, motor transport etc it is not possible to create a response covering just one activity. Janice will investigate possibly creating a specific document together with BHS for equestrians.

9. PUBLIC ACCESS AND ELMS.

Janice asked everyone to note her report. Some consideration was given by the Forum to possibly lobbying Lord Benyon as he is from the local area and is involved in rural affairs. Janice had met with him a few years ago re access and farm payments but maybe now is the right time to make further points to him for instance green belt not necessarily AONB and is the quality of the landscape a consideration? Sharon also commented that there can a difference between farmers and landowners when considering the ELMs scheme.

10. WEST BERKSHIRE ROWIP.

Consultation has currently stalled due to an issue with the consultants. Still outstanding is the exceptional meeting with the Forum outside of the LAF's planned schedule. Janice asked the question of cost of the consultants and evidence of implementation from the last ROWIP 10 years ago. Elaine confirmed the cost is in the region of £9000 and can evidence the use of the ROWIP in planning applications that fall within PROWs.

Action 10: Elaine Cox to inform Forum about the exceptional meeting when known.

11. WBDC GENERAL CONDITION SURVEY.

The entire network is being surveyed between April and June 2022. The consultants are currently drawing up a set of standards that each path will either pass or fail. Although the Ramblers do an excellent job, these 10 yearly surveys require professionals who understand the standards, H&S etc. Training would need to be given to Ramblers.

12. UPDATES ON LONG STANDING RIGHTS OF WAY ISSUES.

- 1. Shaw 3/1. Gate has been moved however the landowner is non-compliant in completing the plan and has been threatened with further action. **Ongoing**Action
- 2. Broad View Farm. The formal application has been forwarded to the portfolio holder for inclusion into case programme for 2022/23. The case has not been considered prior to this due to the length of time taken for submission.

- 3. Streatley FP21. It is unclear whether funding has been sought from 'Mend the Gap'. Margaret would like contact from Paul Hendry and/or Susan Pitman regarding their action. Ongoing action.

14. DISABLED ACCESS WORKING GROUP.

The meeting has not taken place at the Nature Discovery Centre, however a discussion has taken place about the non-viability of the Tramper hire scheme for various reasons.

15. CROSS BOUNDARY LIAISON.

Hants: Helena unable to attend meeting in December, minutes not yet available.

Oxon: Next meeting 18th May, only meet twice a year, currently no representative Simon is happy to attend in May, Janice may go 16th November.

Wilts: Group has not met for over 6 months. Next due in March.

16. WEST BERKSHIRE COMMONS.

Bucklebury: TRO's in place for the winter. More education still needed in some areas. **Wokefield:**

Greenham & Cookham: Park run is back for 6 months being monitored for the effect on the area. Abuse of the common by dog walkers is an increasing problem, more education needed based at the control tower.

17. SNELSMORE COMMON AND LINK PATH

Janice Bridger said that the continued lack of progress was sadly affecting morale. Elaine said she had paid for a purchase order to cover a road safety audit in the area.

18. VERGE CUTTING

WBDC has an ongoing project of wildflower verges, however safety is the first priority. John Winstanley has invited BBOWT to attend our next meeting in May. There is some conflict between continuing with the project and the safety of walkers/riders. WBC - The Forum understands areas have been identified in Wokingham as suitable for wildflower verges. What is the current situation with regard to their implementation?

Action 18: Andrew or Connor to advise Forum of up to date plan.

19. DEFRA AONB PLANNING CONSULTATION

As this covers a significant part of the Forum's area it would be prudent to respond. Janice is happy to draft a response on the relevant questions including Chapter 3 section People & Place. Simon to draft responses relating to motorised traffic and send all proposed responses to LAF members for discussion. Deadline is 9th April, prior to our next meeting.
