The premises designated for the purposes of section 1(1) of the Act are those premises forming part of the undertaking carried on by the Secretary of State on the date the Act came into force and known as the Atomic Weapons Establishment, more particularly described as-

(a) Atomic Weapons Establishment Aldermaston, Reading, Berkshire RG7 4PR (including the separate site forming part of that Establishment at Blacknest, Brimpton, Reading, Berkshire, RG7 4RS);

- (b) Atomic Weapons Establishment, The Mearings, Burghfield, Reading, Berkshire RG3 3RP;
- (c) Atomic Weapons Establishment, Caerphilly Road, Llanishen, Cardiff CF4 5XY;
- (d) Atomic Weapons Establishment, Foulness, Southend-on-Sea, Essex SS3 9XE.
