Dear Sir/Madam,

I have consulted with the emergency planners within Plymouth City Council, which is responsible for the preparation of the Devonport Royal Dockyard off-site emergency plan required by the Radiation (Emergency Preparedness and Public Information) Regulations (REPPIR) 2019. They have provided adequate assurance that the proposed development can be accommodated within their off-site emergency plan arrangements.

The proposed development does not present a significant external hazard to the safety of the nuclear site.

Therefore, ONR does not advise against this development. However, we do support the observations made the emergency planners, which we repeat below for clarity.

- 1. Access should be available for the delivery of stable iodine tablets (SITs) to individual properties in the development. SITs are delivered to individual homes as an urgent protective action, and it is important that a household is able to access any such delivery to their boxes without leaving their home. Any communal door entry system should provide a facility to allow the delivery teams to enter communal areas so deliveries can be made to individual homes.
- 2. All contractors, and sub-contractors, working on site during the construction phase, are made aware of the emergency planning arrangements for the Devonport Site, by reference to the public information booklet. Facilities should be available for contractors' welfare during the construction phase, allowing them to shelter and be able to receive deliveries of SITs should an emergency occur.
