2025 Summer Survey

Summer survey concluded in August 2025.Preliminary results showing improvement over last year, only section showing lower satisfaction being Value for money. Findings to be published on the council's website.

BSIP Capital Scheme Progress:

- **BF2. Upgrade vehicle for zero emissions** Procuring two new electric vehicles for in house services. **ACTION: WBC**
- **BF3. Carbon Neutral Facilities** Electric charging points planned at Council depot and at site in Thatcham.
- BP3. Robin Hood & BP4. Bath Road Calcot Report received about existing conditions
 of junctions, proposed to implement bus priority measures in three phases before end of
 2025.

- BP5. Congestion Hotspots Phase 5 bus stop clearways underway, phase 6 planned,
 158 bus stops have been benefited from clearway improvements. Proposal to reduce bus journey times at Carters Rise, Calcot proposed.

- FS6. Multi-Operator Ticket Scheme TOTO introduced by N&D and Community Connect services.
- OI1. Passenger Waiting Facilities 11 new bus shelters installed,5 have green roofs. 8 shelters in production. Publicity to be released. Parishes/Town Councils can request further bus shelters improvements

- OI2. RTPI Screens Shortlist of sites complied, additional suggestions welcome, investigating procurement options.

- Ol4. Works on Bus Station looking at maintenance contract of the site. ACTION: WBC
- OI5. Bus Gate Review Tender complete for Braemore Close, Thatcham, expected to be live by end of 2025.

- Ol6. Bus Stop Requests Looking at relocating Welford Village stop, gathering patronage information and assessing value for money.

BSIP Revenue Schemes Progress:

- BS1. Downlands Transport South Newbury zone introduced from September 2025.
- BS2 Thatcham Connect now serves West Berks Community Hospital.
- **BS6. Council Supported Services** Changes supported services network to be agreed.

ACTION: WBC

- **BS11. Evening and Sunday Services, Newbury & Thatcham** Extension of 1e service to be agreed, proposed reduction to 2 services a night. Voted on, outcome below.
- **BS12.** Introduction of Evening/Weekend services X34 proposal for Sunday service serving additional villages north of Newbury. Voted on, outcome below.
- **BS14.** Expanded DRT service dependent on outcome of Government Spending Review, to looking at long-term feasibility and funding for any expansion of service areas.

- BS17. 1a/1c Tender complete, going through corporate process. (Update 27/10/2025: the tender exercise is now due to be repeated)

 ACTION: WBC
- SS2. Independent Travel Training –Looking at staff training programme. ACTION: WBC
- **II1. Improved marketing of bus services** Improvements to N&D website, and promotion of 43 service.
- CT1. Community Transport Revenue Grant for Community Transport Groups issued, joint project with CT and Council to issue publicity for volunteer recruitment. ACTION: WBC

Operators Updates:

- Reading Buses Patronage in West Berkshire higher, decrease in short journeys, longer journey staying on similar levels, likely due to increase of the fare cap. Improvements to punctuality and 99.97% reliability of services. Upgrading the Yellow 26 to 100% electric vehicles.
- **Thames Travel** Good performance compared to last year, main issues for X34 is punctuality and reliability along A34, expect service changes in Oxford in February 2026.
- West Berkshire Council

 Overload on 47 on Mondays/Tuesdays, now providing a larger bus on Mondays. 47 now a limited stop service in Swindon. Community Connect Downlands service frequently busy all day.

Other Issues:

- North Hampshire Villages —Council liaising with VCWB about potential solutions for North Hampshire following withdrawal of 7/7a service. ACTION: WBC & VCWB
- Young Carers and Care Leavers Request for suggestions to help young carers and care leavers, VCWB transport group of young carers in the evening once a week.
- **Poverty Forum** New initiative for West Berkshire, request for public transport suggestions that may be of benefit. Reading Buses have scheme for Job seekers.
- Request for BSIP capital/revenue Expenditure Operators to send suggestions, WBC to provide a list of suggestions to members of Forum.

 ACTION: WBC & Ops

Proposed changes to EP Scheme: Annex A and B:

- Add Carters Rise, Calcot to list of Congestion hotspots in EP Annex A. Covered under Bus Gate section so wasn't previously considered, move so other improvements can be considered. Voted on, outcome below.
- Remove reference to Parking Strategy within EP Annex A, following withdrawal by Council Members. Voted on, outcome below.

- **X34 Sunday extension** Decision deferred as further detail about proposal to be shared, written decision prior to next forum, update provided in next Forum notes.
